## **Trade-in Full Terms and Conditions**

- 1. Actual trade in value will vary dependant on device, value to be agreed at point of Trade-in
- 2. Offer only available in Curry's PC World Republic of Ireland Stores
- 3. If you trade in your old item ("Device") you will be eligible to receive trade in value in the form of a Currys PC World electronic gift card "eGift Card" from the following dates:-
- A) Wednesday 30th January 2019 to Tuesday 2<sup>nd</sup> April 2019 for Windows and Surface Trade-in.
- B) Wednesday 30th January 2019 to Tuesday 12th March 2019 for Apple Trade-in
- 4. You will be deemed to have accepted these terms and conditions ("Conditions") when you provide us with the device. If you have any questions relating to these Conditions please ask in store before completing the trade in process.
- 5. You confirm you are either the owner of the Device or you have obtained express permission from the rightful owner to trade it in.
- 6. Devices must not be older than 7 years.
- 7. Devices must meet the criteria for working devices and if any of the criteria is not met, trade in may be refused. Your device must be intact and with no obvious faults. It must power on and off and you must have the power supply and plug. The screen must be in full working order, with no cracks, damage or faults. The device must be fully functioning.
- 8. The Device must not be stolen or listed with us or a third party as stolen. For some items we will check the device with CheckMEND, from the suppliers of IMMOBILISE as used by an Garda Siochana Republic of Ireland Police forces to trace stolen and missing property. If the device fails any due diligence check we may notify the relevant police authority and we may pass the device and your details to them and the value may be cancelled or recovered.
- 9. If the Device contains any additional accessories (eg. memory cards or additional console controllers), you must remove these prior to trade in. We will not be liable for any consequence of you not removing the accessories, including any payments associated with the device
- 10. If there is data stored on the Device (e.g. Photos', Contacts, Music, Videos & Graphics etc.) you wish to retain, it must be saved elsewhere and you must remove any memory card and/or all data that has been put onto the Device prior to trade in. We will not be liable for any damage, loss or erasure of any such data or for any consequence of you not removing your data or memory card, including use or disclosure of such data.

- 11. The eGift card must be used as part or full payment in a Currys or PC World store to purchase a new Windows laptop, or Apple Mac. The new laptop must be purchased at the same time as you trade in your old device. Any balance remaining on the eGift Card expires after 2 years.
- 12. The eGift card cannot be exchanged for cash.
- 13. Once you have traded in the Device, it becomes our property and it will not be possible to retrieve it under any circumstances.
